Dear Sir:

We represent the above-captioned individuals, all owners of common shares of Les Ressources Campbell Inc., who have instructed the undersigned to communicate with you in your capacity as the Court appointed sequestrator to the assets of Les Ressources Campbell Inc. and Ressources MSV 2007 Inc., with respect to the following matter.

In light of credible information received by our clients and/or their duly authorized representatives, our clients harbour most serious concerns regarding the fact that the assets of, in particular, Ressources MSV 2007 Inc., wholly owned subsidiary of Les Ressources Campbell Inc., have not been properly administered and valued up to the

time you were appointed sequestrator, the whole to the detriment of our clients' rights and interest. In this regard, our clients consider that the affairs of said companies have been conducted under a cloak of secrecy to the prejudice of its shareholders.

You will no doubt agree that it is imperative that the administration of the assets of the aforesaid companies be conducted in a most transparent manner. To this end, our clients consider that it is essential that the appropriate steps be taken by you immediately to engage the necessary experts to conduct a new independent study in order to properly establish the current real value of the assets of said companies, and in particular but without limitation, the assets of Ressources MSV 2007 Inc. Such an independent study would ensure that the protection of the interests of all the creditors of said companies is maximized.

In addition, the aforesaid concerns expressed by our clients extend to the administration of Meston Ressources Inc., a wholly owned subsidiary of Les Ressources Campbell Inc., which company was declared bankrupt on or about September 28th, 2009, the trustee appointed in respect to said bankruptcy being Raymond Chabot Inc.

Would you be kind enough to communicate with the undersigned upon your receipt of this letter in order that you may provide an overview of your administration to date and further confirm that you have conducted, or are in the process of conducting, a new independent study of the assets of the above-captioned companies.
